

TERMS and CONDITIONS and AGREEMENT of USE:

By becoming a registered user of VSAS and by using the VSAS system, you agree to the Terms and Conditions of Use below:

VSAS is an video sharing and analysis platform earmarked for the sporting industry. Through registration as a user, the user agrees that any amendment, addition, modification or variation of any video loaded and shared or personal information is carried out solely by the user or a person authorized by the user.

Registration on the system is completed once proof of payment has been received by the system administrator. An access identification username and password will then be provided to the user for access and use of the platform.

The user will then have to agree to the Privacy Policy and the Terms and Conditions of Use because access is finally granted.

All member users can then upload, review, update and/or modify their videos and personal information immediately on the secure platform. Any changes will reflect immediately.

Our privacy policy provides for the safeguarding of VSAS user's information and prohibits its distribution (selling, loaning or renting) to any party in any form except for the purposes for which a user has subscribed.

USER'S RESPONSIBILITY to DATA ENTRY and SHARING of INFORMATION:

It remains the responsibility each user to enter, confirm and maintain his/her own videos and personal information on the VSAS system, to keep their data current, accurate and complete.

The user decides with whom to connect and what videos are shared and is visible with that connection.

All passwords are encrypted and data are transmitted securely utilizing SSL the latest 128-bit technology offering the highest level of encryption security possible.
